Certification Maintenance (CM) providers are educational organizations approved by AICP to provide continuing education activities and events for CM credits. All education providers, including APA and its chapters and divisions, must apply to become CM providers.

When seeking accreditation for an educational activity, the CE developer must identify a group of experts that represent the activity's target audience. This planning committee will help design and implement the educational activity and must include a representative for each type of CE to be offered.

Roles and Responsibilities of Planning Committee Members

All planning and design of the CME activity will grow from the goal and purpose, including the methods of needs assessment, development of learning objectives, selection of content and instructional design, and methods of outcomes measurement. The educational need for each activity must be substantiated.

Although they may be worthwhile for physicians, continuing education activities related to a physician's nonprofessional educational needs or interests, such as personal financial planning or appreciation of literature or music, are not considered CME content by the ACCME.

CME Content: Definition and Examples | ACCME

Continuing Education Units (CEUs) are awarded on the basis of 10 student contact hours equaling one Continuing Education Unit. Certificates of completion are awarded for specific educational activities which do not meet standards for CEU awards.
